Information about Payment Methods

Dear fellow member of the EUROAVIA Alumni Association, welcome to our network! We appreciate to have you as a member of our society, which follows the EUROAVIA roots and will enlarge your EUROAVIA experience as well as professional contacts.

To get covered all our regular costs of the Association, the foundation meeting on June, 3rd 2016 in Berlin has approved to have an anual fee of 25 Euros for all members. Donations further to this amount can be indicated, but are not mandatory. A donation certificate can be asked for, but in most European Countries, the transfer receipt is sufficient for your authorities.

Currently we are settling up the organisation. This is a huge amount of formal processes which are sometimes faster, sometimes slower.

As no SEPA Direct Debit System (SDD) is yet installed, but for those members of you who are willing to use this payment method, we are informing you as soon as we can offer this payment method.

For the membership fee which will be collected at the beginning of each year, a bill will be provided and a possibility to transfer this amount on our account via Stripe is offered on the website (<https://alumni.euroavia.eu/membership-fee-payment>). Please keep in mind that those services include extra costs, we have to take over. So your membership fee cannot be used completely. A SEPA Direct Debit Mandate is both convenient for you and helps us to save transfer costs and extra work for the billing.

If you live in a country which does not offer SEPA methods, the bill and Stripe is currently the only way to transfer the amount to us as SEPA cannot be applied. International Bank transfers arise huge amount of transfer costs. We are working on alternative ways for payment, too, to ease the way of paying the membership fee.
